

## **Advertising Terms and Conditions**

- 1.) The booking/order form is a contractual agreement between the two parties: the advertiser and the client.**
- 2.) The signatory declares that he/she has the authorization to sign for and place advertisements on behalf of the client and is aware of the costs for such advertisements.**
- 3.) The agreement is a firm order and is not subject to cancellation unless agreed upon by both parties.**
- 4.) Any form of action will fall within the jurisdiction of the magistrates' court.**
- 5.) All outstanding accounts will attract an interest fee of not less than 1% per month and is usually calculated at the prime lending rate plus 2% per annum.**
- 6.) The client is required to respond within 7 (seven) working days upon proof. Failure to respond will result in your entry being published as is.**
